MINUTES OF THE BOARD OF HEALTH MEETING OF DECEMBER 12, 2011

The Board of Health held a public meeting on December 12, 2011. Sandra Lee Tompkins, Rebecca Lovell Scott & Francis J. Sheehan, Jr., M.D. were the Board members in attendance. David B. Mason, Health Agent was also present.

The proponents had submitted a document entitled Town of Sandwich Certificate of Water Quality Compliance dated 12-6-2011 prepared by Lightship Engineering

Attorney Kirrane addressed the Board and gave a brief overview of the proposal.

Mr. Pierdinuch gave a brief synopsis of the document prepared by his firm.

After discussion, the Board members unanimously approved the issuance of the Certificate of Water Quality Compliance (CWQC). The motion was made by Ms. Tompkins and seconded by Dr. Sheehan.

The CWQC was granted with the following stipulations:

- The CWQC is Non-Transferable
- Auto Body Work/Painting is Prohibited
- Sandwich Health Department and Sandwich Fire Department must be notified of changes or additions of hazardous materials and how such hazardous materials and waste are to be managed.
